
## From Hazlehurst, Baxley, or Jesup:

You will travel on US Hwy. 341 South/Golden Isles Parkway towards Brunswick, GA.

In Jesup you will stay on the US Hwy. 341 South Bypass. You will continue through Jesup on the bypass until you reach the traffic light across from the Chevron/McDonalds. At the traffic light you will turn to the left and proceed straight on US Hwy. 341 South until you reach Brunswick.

Once you reach Brunswick, continue going straight past all the hotels and food chains (restaurants) until you reach the Old Downtown District.


Going into the Old Downtown District you will go to the 2<sup>nd</sup> red-light where you will turn left on GLOUCESTER ST. After turning left on GLOUCESTER St., you will travel approximately two blocks. You will see a tall building on the Right named the FRANK M. SCARLETT FEDERAL BUILDING/US POST OFFICE. This is the Courthouse.






### From McIntosh County or Glynn County, GA (Traveling on US Hwy 17 S):


Travel South on US Hwy. 17 towards Brunswick, GA. At the intersection of US Hwy. 17 and Gloucester Street, you will turn Right on Gloucester Street. Once on Gloucester Street, you will travel approximately .08 miles. You will see a tall building on the Left named the FRANK M SCARLETT FEDERAL BUILDING/US POST OFFICE. This is the Courthouse.





## From Glynn County or Brantley County, GA (Traveling on Hwy. 82 E)


Travel on US 82 E towards Brunswick. US 82 E will turn into US 17 N. You will travel across the Sidney Lanier Bridge and continue on US 17 N until you reach the first Stop Light. At the intersection of US Hwy. 17 and Gloucester Street, you will turn Left on Gloucester Street. Once on Gloucester Street, you will travel approximately .08 miles. You will see a tall building on the Left named the FRANK M SCARLETT FEDERAL BUILDING/US POST OFFICE. This is the Courthouse.





#### From Camden County, GA

Take I-95 North until you reach Exit 29. After you take Exit 29, you will turn Right onto US 17 N. You will travel across the Sidney Lanier Bridge and continue on US 17 N until you reach the first Stop Light. At the intersection of US Hwy. 17 and Gloucester Street, you will turn Left on Gloucester Street. Once on Gloucester Street, you will travel approximately .08 miles. You will see a tall building on the Left named the FRANK M SCARLETT FEDERAL BUILDING/US POST OFFICE. This is the Courthouse.





After you find parking, on the street or parking lot, then walk around the building to the side entrance for the Court House. You must have your ID for the security officer at the door. You will also be going thru a metal detector so make sure you leave any belongings not necessary in your automobile.
